VIP DRIVEWAY GARBAGE SERVICE WAIVER

I, _____, A Customer of Ward Waste Solutions LLC ("Ward Waste"),
by signing below, I understand and agree that:

(1) I have read and understand Ward Waste's Service Agreement

(2) VIP Driveway Garbage is a SPECIALTY service offered in limited service areas, not all customer addresses meet all of the requirements to qualify for VIP Driveway Garbage services. Ward Waste retains the right to end this specialty service at any time, for any reason, and refund any remaining credit on the account.

(3) ALL Garbage must be Bagged. Loose garbage will not be collected

(4) VIP Driveway Garbage Service is considered "Cart Only" service. "Cart-Only" is defined as the Cart lid should be completely closed; If you have a bulk item pick up you should contact your Ward Waste Specialist to get that scheduled for pick up.

(5) All garbage carts shall be: *Closed, secure and placed on street level (i.e. not up or down stairs);
*Freely and safely accessible/not placed inside closed buildings or a gated area, and within 10ft of a drivable surface; and not in a place where resident dogs or other animals will encounter service providers.

NOTE: All safety risks will be assessed and pick-up determination will be made by the collector at the time of collection. Vehicle blockage or snow may prevent service. A notice will be provided on the container or by electronic/mail/phone if any issues prohibit service.

(6) Ward Waste Solutions has my permission to collect and dispose of residential solid waste from my premises; I warrant that my pavement, curbing, or other driving surface or any right of way reasonably necessary for Ward Waste to provide the services described herein are sufficient to bear the weight of all of Ward Waste's equipment and vehicles reasonably required to perform such service. Ward Waste will not be responsible for damage to any such pavement, curbing, driving surface, or right of way, overhead and/or side objects such as electrical wire, phone lines, overhanging roof lines, walls, corrals, etc., whether such objects are within the lot line or a neighboring property, and I agree to assume all liabilities for any such damage, which may result from the Ward Waste's vehicles and equipment providing service at my location, including by way of example only, spills, leaks, broken cable line, and cracks in pavement. I agree to defend, indemnify, save and hold harmless, Ward Waste, officers, employees and agents, to the fullest extent permitted by law, of and from all claims, loss, damage, injury, suits of whatever nature, for personal injury and property damage alleged to arise out of, or any conditions, of the work performed, that are or may be brought by parties not subject to the terms of this agreement, specifically neighboring real or personal property owners, who alleged to have suffered a loss as a result of performing the duties enunciated herein.
